The Nebraska Department of Agriculture, the Nebraska Grain and Feed Association and the National Grain and Feed Association are hosting a seminar to assist the Nebraska grain and feed industry with analysis of the FDA's Food Safety Modernization Act (FSMA) regulations that apply to domestic and foreign facilities that manufacture, process, pack or store animal feed as well as pet food. In addition, the seminar will provide an update on the status of FDA's judicious use of antimicrobials regulations; and, its impact on feed manufacturers and distributors.

SPEAKERS



David Fairfield joined the National Grain and Feed Association (NGFA) staff in July 2001 after spending 20 years managing operations for major U.S. commercial feed companies. As senior vice president of feed services, he is NGFA's primary staff person that addresses feed/food safety and operational issues. David participates as a subject matter expert within a variety of animal food safety forums, including those associated with the Association of American Feed Control Officials, Global Food Safety Initiative, and the International Organization of Standardization (ISO). David currently serves as the chair of the animal food-related activities within the Food Safety Preventive Controls Alliance, which is developing guidance and training materials to effectively implement regulations being promulgated under the Food Safety Modernization Act. David is a magna cum laude graduate in feed science from Kansas State University's Department of Grain Science.



Matt Frederking is the Vice President of Regulatory Affairs at Ralco based in Marshall, MN. Frederking is an International HACCP Alliance Lead Instructor and was instrumental in developing the HACCP training course taught at Kansas State University (KSU). He continues to teach HACCP courses at least once a semester at KSU for grain elevators, feed mills, ethanol plants, feed ingredient suppliers and other allied industry members. He serves as an adjunct faculty member at Kansas State University. Frederking also currently serves as a member of the National Grain and Feed Association's Feed Legislative and Regulatory Affairs Committee and is chair of the Feed Manufacturing and Technology Committee. Additionally, he serves as a member of the American Feed Industry Association's Feed Regulatory Affairs Committee, Ingredient Definitions Committee and International Trade Committee.
